General Rules

Each participant in the parade must comply with the following rules. Should any participant refuse to obey the rules, their entry may be removed from the parade, and their group may not be invited to participate in future events. It is the responsibility of the Entry Coordinator to ensure that all participants within their entry are aware of the general rules.

Please read and initial each rule below:

1. ____ The Parade Application, Rules, and Entry Fee must be submitted by their group representative by **Saturday, November 21, 2026**, to be eligible.
2. ____ No objects may be thrown, sprayed or distributed along the parade route. No candy, silly string, or handouts of any kind. **NO EXECPTIONS.**
3. ____ **Floats are not allowed to use or display any flammable items, no sparklers or fireworks allowed.**
4. ____ Each Entry is required to follow all CDC COVID related guidelines that are in place at the time of the parade.
5. ____ No Santa Claus imitations permitted. **INSURANCE RESTRICTIONS DO NOT ALLOW ANIMALS IN THE PARADE.**
6. ____ Entries will receive confirmation with all assembly, disband, and parking instructions no later than December 1st.
7. ____ One representative from your entry must sign in at check-in prior to 5:30 pm on the day of the parade or will risk not being able to participate. All others in the group are to meet at their staging area and must be in formation 30 minutes prior to the start of the parade. The parade order is at the discretion of the parade officials.
8. ____ Please maintain 20 feet between your entry and the one in front of you to ensure the pace of the parade.
9. ____ No smoking or alcoholic beverage on any parade entry at any time.
10. ____ The entry coordinator must agree, sign, and share with those in their group the "General Rules."
11. ____ The Parade Officials reserve the right to refuse or remove any entry, which, in their opinion, does not conform to any of the parade rules.
